Dear Friends,

We are pleased to share with you the successes of this past year. In 2019, we provided hope and support for more youth and families than ever before. Through our more than 70 programs, Pressley Ridge directly impacted the lives of 10,136 individuals in six states.

Of the 2,500 children and adults who were discharged from our services this year, 96% left feeling they had a close family and strong support system in place. This is evident through the success stories you will read in this year's report, including:

- Raeshawn, who is completing his sophomore year of college after spending his teenage years in foster care
- Clauderissa, whose experience in the Independent Living Program helped her find direction and purpose in life
- The 60+ students who are now able to learn and prosper in a school that was designed specifically for their unique needs

These successes, along with thousands more untold stories, are possible because of the foundations, companies, individuals, families and our own employees and board members who invested in our mission. Community support allowed 60 kids to attend our therapeutic summer camp in Cincinnati and brightened the holidays for more than 1,100 youth.

Corporations and foundations enabled us to bring together more than 150 mental health professionals for a crucial conversation on the future of trauma-informed care. And the efforts of countless people opened the doors to new possibilities for the students at our brand new School for Autism and School for the Deaf.

Your time, talents and treasures – no matter the size – inspired hope for thousands of people this year, and on their behalf, we thank you for believing in Pressley Ridge.

We are proud of the lives we have changed over the past 188 years but know there is still a great deal of work to be done. With your support, we can continue doing whatever it takes to create success for even more children and families.

Our Services



Community-Based Mental Health Services

Individualized services designed to strengthen, preserve and keep families together in order to overcome whatever challenges they may be facing, so that children can remain at home, and in their own schools and communities. Office-based and school-based outpatient mental health services support children, adolescents, adults and families in the community.



Private Academic Schools

Education with an individualized, strength-based, holistic approach to academic and behavioral growth with an added focus on social and life skills to help students reach their maximum potential. Specialized services include education for students with serious emotional and behavioral challenges, as well as children impacted by autism and those who are Deaf or hard of hearing.



Foster Care and Adoption

Trained foster parents ensure children are safe and well cared for in a secure and stable home while we work to reunite them with their biological families or find an adoptive family when reunification isn't an option.



Residential Treatment Services

Short-term programs in a supportive live-in environment with 24-hour treatment staff to help youth learn the skills that will enable them to return home, strengthen family relationships and become better connected to their community. Services include working with the biological family in order to ensure a successful transition home.



Supportive Services for Transition-Age Youth

Programs offering youth between the ages of 16-24 the essential skills and support to make a sound transition into adulthood, including workforce development and independent living.

Success Stories

Raeshawn

Raeshawn faced many challenges in his early childhood years, including developmental trauma that ultimately led to being removed from his family's custody at age 12. His first placement in a residential treatment facility was the catalyst for Raeshawn to want more out of his life, and he became committed to improving his behaviors and performance in school.

As he was entering 8th grade, Raeshawn was placed in a Pressley Ridge foster home. His new foster mom echoed his desire to succeed in school, and she encouraged Raeshawn to apply for enrollment at Ginn Academy, an all-male public high school in Cleveland.

At Ginn Academy, Raeshawn was able to focus on academics while learning discipline and leadership. He joined the basketball team, serving as team captain his junior and senior year and leading his team to a Conference Championship. With the help of his foster mom, Raeshawn successfully ignored the distractions of his peers. As many of the kids in his neighborhood turned to the streets and gang involvement, he was determined to focus on academics and succeed in the classroom. Despite a change in foster homes during his senior year, Raeshawn continued to excel at Ginn Academy, even when it meant taking public transportation over an hour each way to school.

Though he had previously been resistant to the idea, Raeshawn was convinced by his new foster family to enter into therapy with Pressley Ridge. Over time, he built a strong therapeutic alliance with his therapist and was able to address the trauma symptoms that were affecting him. Raeshawn also worked with his therapist and foster brother to develop a young men's council at Pressley Ridge in Cleveland. As the eldest founding member of the Men of Honor & Integrity group, he

quickly became a “big brother” to several foster boys. The relationships Raeshawn formed with his fellow group members created a strong sense of community and brotherhood. His continued leadership and support of this group has allowed him to serve as a mentor for new members.

Raeshawn graduated third in his class from Ginn Academy in 2018. He was awarded a full-tuition scholarship to Cleveland State University (CSU). The Sullivan-Deckard Scholarship is a program designed for former foster youth to attend CSU at no cost and to receive the additional supports needed to be successful in college. Upon emancipation from foster care, Raeshawn was able to enroll in Pressley Ridge's new Bridges Program, which is designed to provide support and guidance for transition-age youth who have emancipated from foster care.

Raeshawn is now a sophomore at CSU majoring in Urban Studies with hopes of giving back to his community. He remains connected with his Pressley Ridge therapist and mentor, as well as many of the ‘brothers’ he gained from the Men of Honor & Integrity group.

Clauderissa

“I entered foster care at the age of 16. I was dealing with a lot of issues with my mom, so it just wasn’t the best of situations. I entered into independent living [with Pressley Ridge] at the age of 18, where I met Mr. John, Mr. Torrey and Ms. Tina.

Coming from foster care, you’re alone, you’re scared, you’re vulnerable—so, you put up a guard. But they didn’t let me... They didn’t allow me to build that wall up from them.

I only had a couple of months until I aged out [of foster care], and I was working jobs and saving up money, but there was something inside me that didn’t really feel complete. Through this whole journey, I always thought ‘what is a life if you’re not giving back or helping someone else’s life?’. That’s when I had a talk with a member of Pressley Ridge, Mr. Mike, and he brought up the military. I sat down that night and emailed a recruiter. She laid out a bunch of options for me—reserves, full time. I thought, ‘I’m aging out soon, and I want a solid foundation for when I age out. I’ll go active.’

She scheduled me to take a test, and I thought ‘how hard can it be?’. I went in to take my first test, and I failed. I failed badly. I failed to the point that it was embarrassing.

I just wanted to quit, but my team didn’t let me give up. They saw something in me that I didn’t see; that I still don’t see. They got me a tutor, and I took a month or two to study. Once you take the first test, they make you wait 30 days to retest. So, now it had been about three months and age-out time is just around the corner. I went in for the second test...and I failed.

At Fort Mead, there is this red room, it’s the swearing-in hall, and I remember every time I left, I wanted to just put my feet on the red carpet and raise my hand and be there in the moment. So I decided to give it another try, and once again, [my team] didn’t allow me to fail.



I got in there, the third time of taking my test, and the whole time while taking it, I was thinking, ‘You failed once again. You let people down. You wasted money. Just stop right now, give up and walk out.’

I remember clicking submit and walking down past the Navy office, Army, Coast Guard, Marines and glass windows everywhere. I walked in to my recruiter... and she was jumping and screaming ‘oh my gosh, you passed!’ I had passed by one point!

I can’t thank [my team] enough. It’s been incredible. You all gave me so much strength and hope.”

Success Stories

A New School

When the students at the Pressley Ridge School for Autism and School for the Deaf arrived on the first day of the 2019-2020 school year, they made history.

For the first time, they entered the hallways of a brand new school building that was designed especially for them. With clear sight lines, round tables, adjustable lighting and soft, comforting furniture, each and every space in the building was created with the help of Deaf and autism experts to ensure the success of our students.

While the students began classes earlier in the month, the school officially opened with a ribbon-cutting ceremony on September 20th. Donors and supporters, including several local officials, joined staff and board directors to celebrate the years of hard work and dedication that made the school a reality. Students Antonio Curcio and Tahjay Banks also shared their excitement in finally having a place to learn that supports their needs.



Antonio spoke of the amenities the new school has to offer, saying, "I like the new school because it's different. We have our own floor and hallways. We have our own culinary room with two microwaves, two stoves and a coffee shop. Every classroom has a calming room to calm students when they are getting worked up."

Antonio's school, Pressley Ridge School for Autism (PRSA), occupies the second floor of the new facility. Here, students ages 6-21 with Autism Spectrum Disorder receive intensive social, behavioral, and academic interventions to learn the skills needed to be successful participants in their communities.

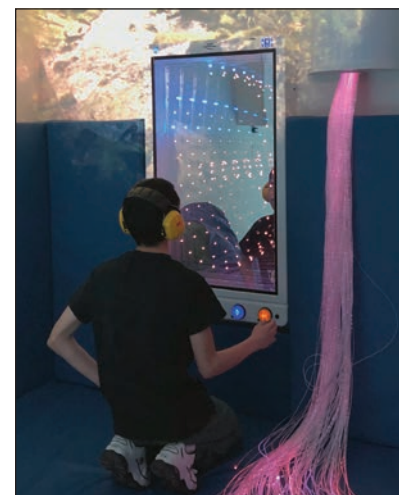
Pressley Ridge School for the Deaf (PRSD), located on the third floor, serves students who are Deaf or hard of hearing and also have behavioral or emotional needs, are on the Autism Spectrum or have intellectual disabilities. PRSD, which is the only school of its kind in Pennsylvania, focuses on each individual student's strengths, emphasizes access to language and communication and employs hearing-assistive technology.



Many of the PRSD students also reside in cottages on the Pressley Ridge campus. Previously, PRSD residential students had to be transported to the former school building nearly 20 minutes away. Tahjay appreciates the convenience of the new school. "We got so tired of getting in the van and going back and forth to our old school. Now we don't have to do that. We can just walk across with the staff."

All classrooms are equipped with SMART Board® technology, calming areas and separate restrooms. Sensory rooms provide interactive materials, including a platform swing, fiber optics, and Sensory Magic™ technology.

The shared first floor features computer/media labs and special classrooms for STEAM (Science, Technology, Engineering, the Arts and Mathematics) and culinary education. A student-run coffee shop and PAES (Practical Assessment Exploration System) Lab allow students to acquire job skills through hands-on experiences in a simulated real-world work environment. Students, like Antonio and Tahjay, also learn life skills in a full-service hospitality-level kitchen and laundry. Office space, conference rooms, a cafeteria, and a large multipurpose room for physical education and performances are also located on the first floor.



Since the schools began serving students (PRSD in 1996 and PRSA in 2002), they have changed locations multiple times, leasing space and moving as needs changed. The students and their families are grateful to finally have a state-of-the-art school that will help them learn more efficiently and effectively. The new building is located on our Pittsburgh Campus, along with the Pressley Ridge Day School Pittsburgh, Family Counseling Center, playground areas, an adventure garden and ample green space.

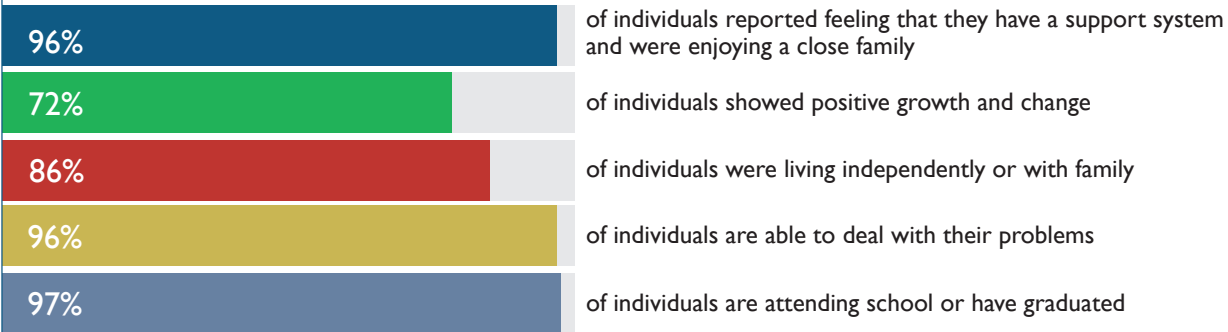

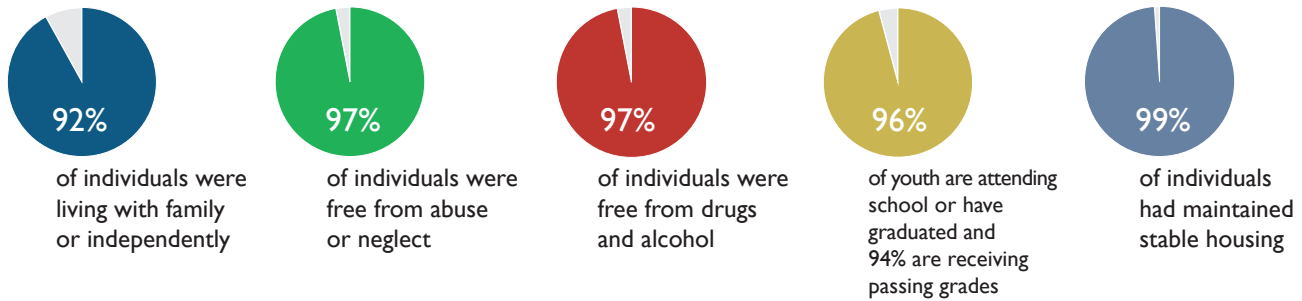

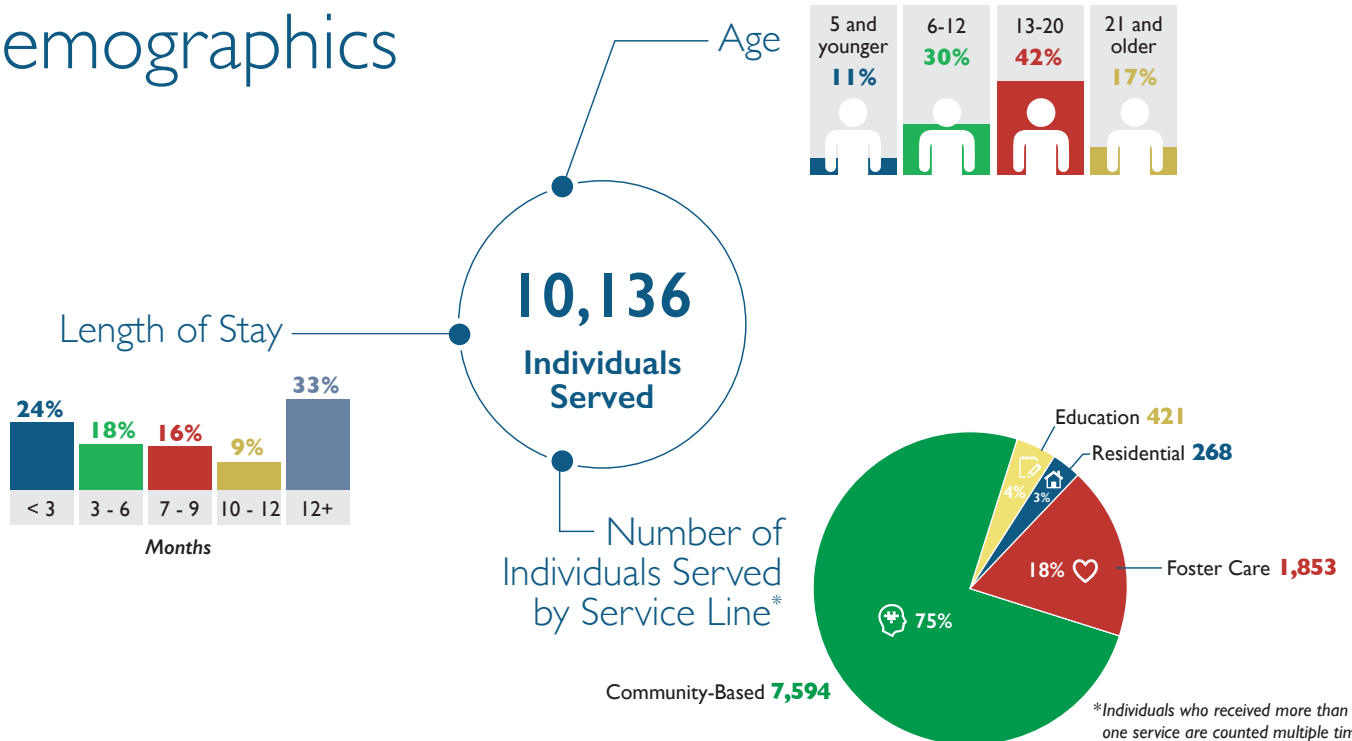
Upon Completion of Services (Measure of Impact Achieved)



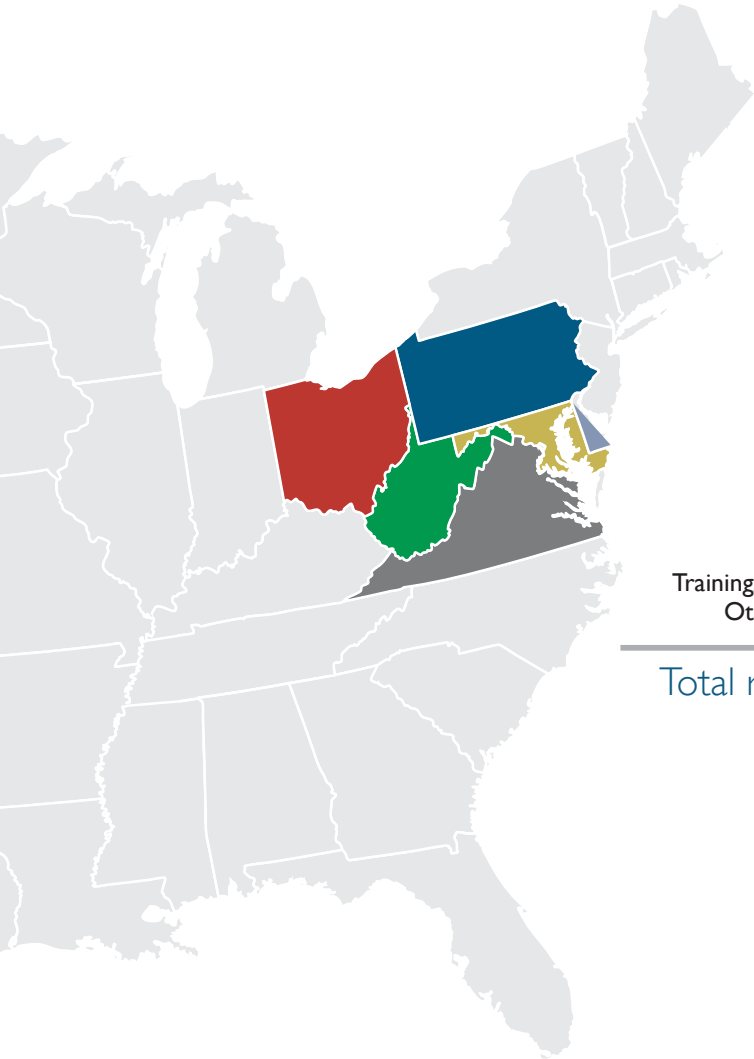
At One Year Follow-Up (Measure of Sustained Impact)

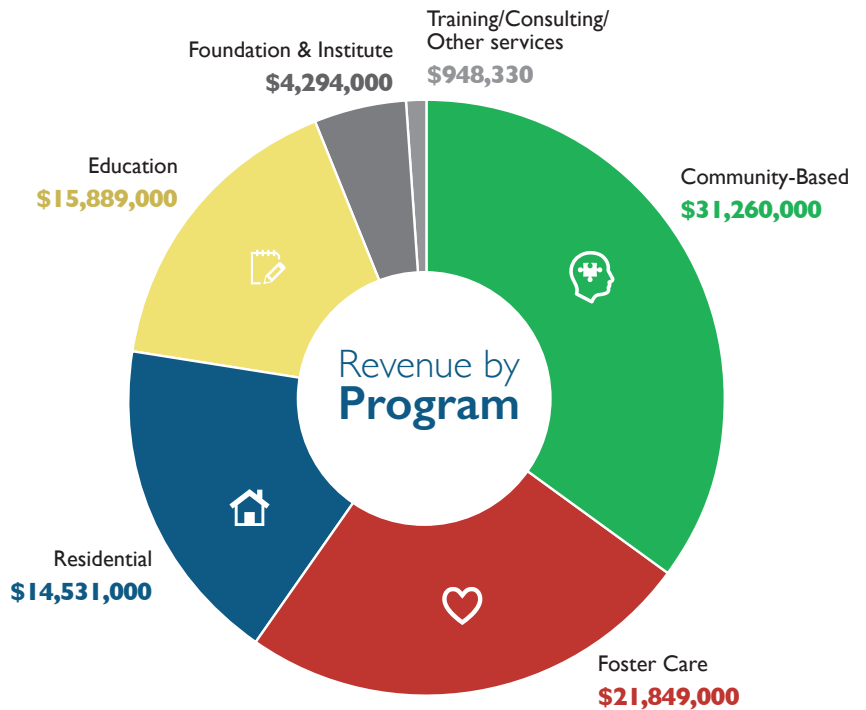
